Rules:

- The competition is limited to instrumentalists only. However, any musical instrument is allowed.
- There is a **MAXIMUM** time limit of **8 minutes** for any piece. Failure to finish in 8 minutes will result in deductions.
- There is a **MINIMUM** time requirement of **4 minutes**. Failure to meet that requirement will result in deductions.
- Selection of music is left to the instrumentalist and may be **any** piece of music including your own composition. A medley of two or more pieces is permitted; however, the composition should be as seamless as possible flowing from one piece to another.
- Judging will be based on the following criteria: Musical Ability, Musical Sound, Stage Presence, Musical Selection, Musical Empathy.
- **The Decision of judges is final.** There is no appeal.
- *The purpose of the competition is to determine that musician who best shows his or her talent and love of music.*

Requirements:

- Applicant must be a **High School Senior** who attends a high school (public, private or home schooled) and/or lives within the boundaries of District 5300.
- He or she has a reasonable ability to play a musical instrument.
- He or she must be sponsored by a District 5300 Rotary Club in order to be eligible for awards.
- Applicant plans on using the scholarship award for future educational expenses.

Regulations:

- Competing students must win at each level of competition to be awarded the top prize.
- Each student must provide his or her own accompanist and will be responsible for any subsequent room, board and travel of him/herself and his or her accompanist.
- Winners at the regional level will be provided limited room and board when appearing at the District Competition.
- Prizes at the club and regional level are at the discretion of the individual clubs and regions, as will any decisions to subsidize any travel, and/or room and board by the sponsoring clubs.

Competition starts at the club level, winners at the club level will move onto regional competition. Winners of one of 4 regional competitions will move on to the District Competition on June. The winner of the **Club** competition will be awarded \$200 and the runner-up will be awarded \$100. The winner of the **District** will be awarded the top prize (as much as \$5000) and the three other participants will be awarded as much as \$1500.00 each. Awards will depend on the number of clubs and participants sponsored.
